




#### 1.2 GROSS VALUE ADDED (ABSOLUTE VALUES)















#### 3.2 CASH FLOW STATEMENT. DETAIL OF EXTERNAL FINANCING FLOWS (2012-2020)









3.6 NET RESULT EVOLUTION. BREAKDOWN OF SECTORAL CONTRIBUTION (2019-2020)




#### 3.7 NET RESULT EVOLUTION. BREAKDOWN OF ITEM CONTRIBUTION (2019-2020)
