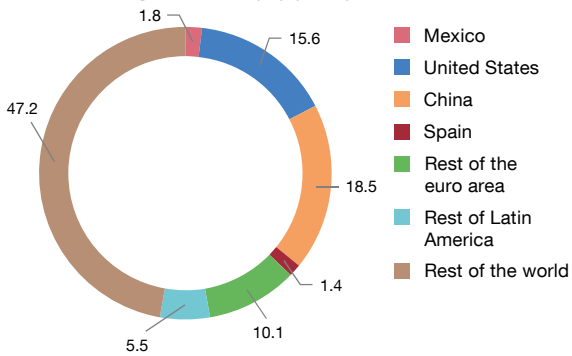

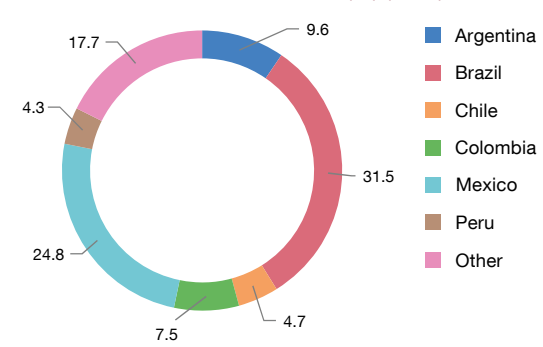

Mexico: structural economic data

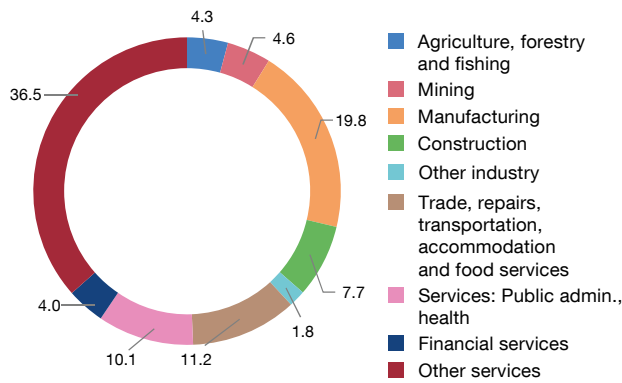
1.a Share of global GDP (%) (2022)



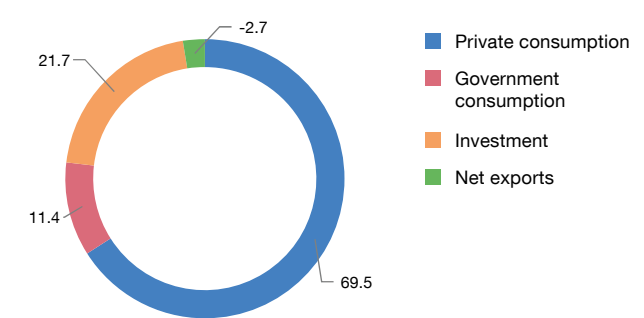
1.b Share of Latin American GDP (%) (2022)



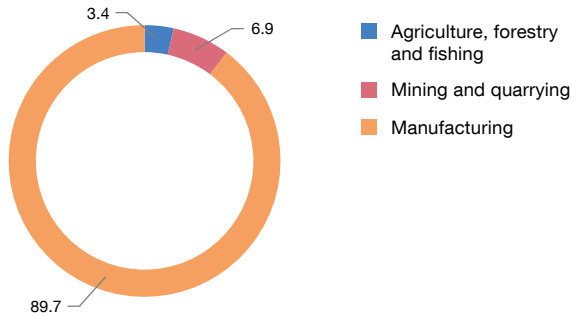
1.c Breakdown of GDP: supply (%) (2022)



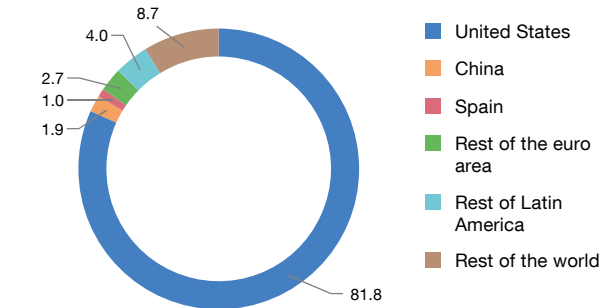
1.d Breakdown of GDP: demand (%) (2022)



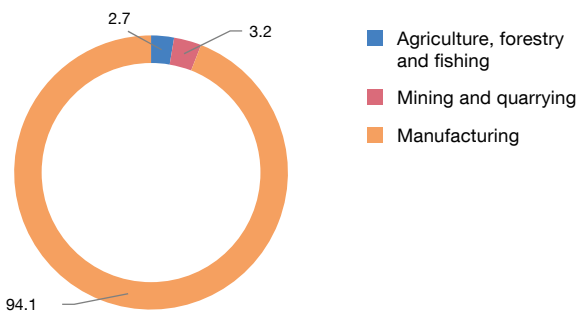
1.e Exports of goods, by sector (%) (2021)



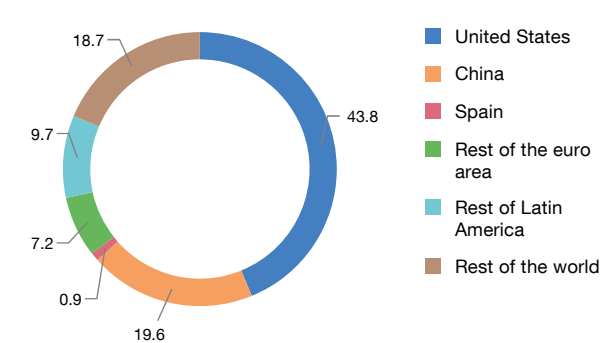
1.f Exports of goods, by destination (%) (2022)

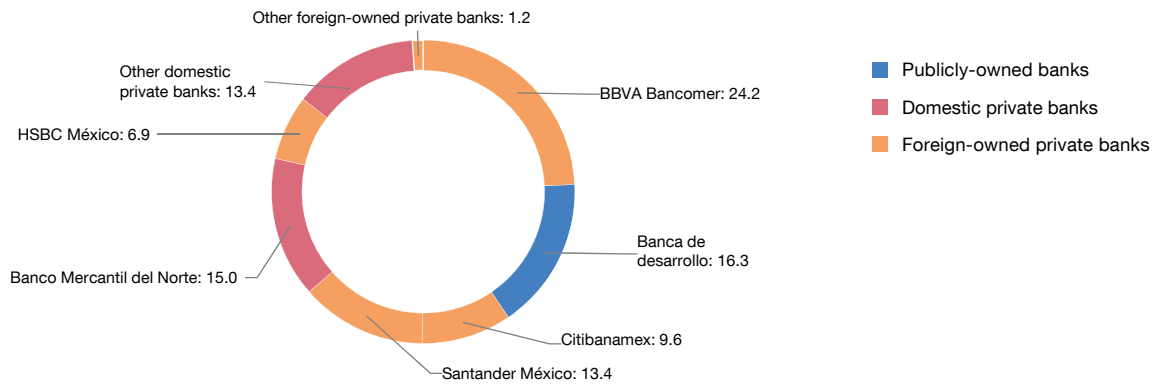

Mexico: structure of the banking sector and relevance for Spain

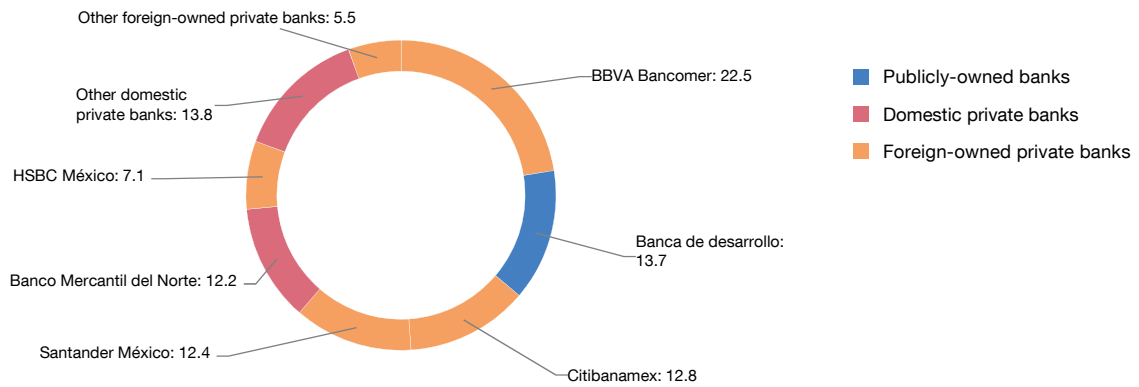
2.a Breakdown of the Mexican banking sector (December 2022): loans

% of the total

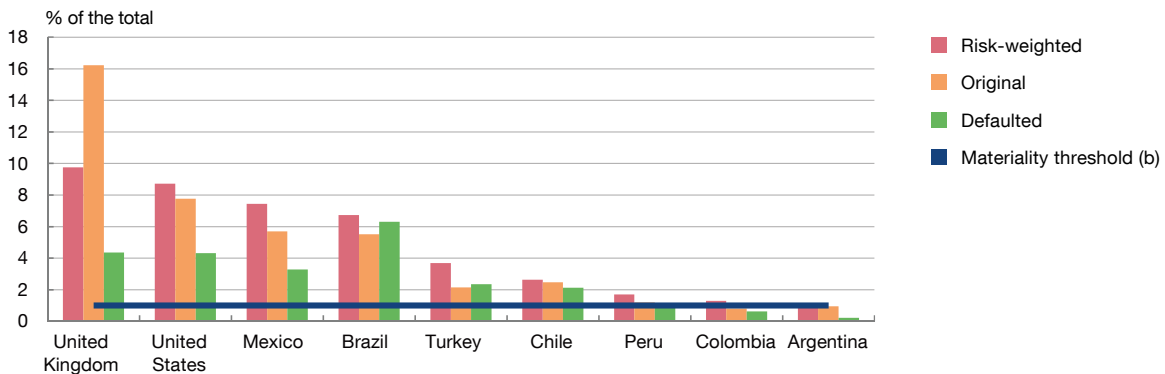


2.b Breakdown of the Mexican banking sector (December 2022): deposits

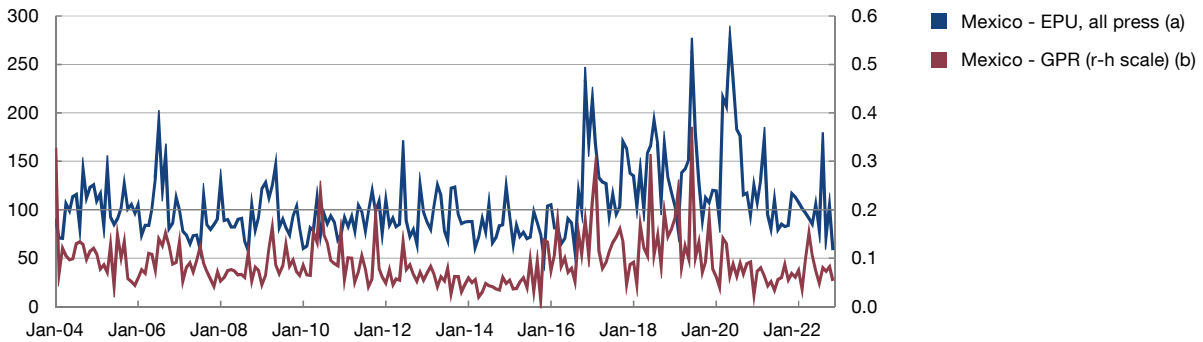

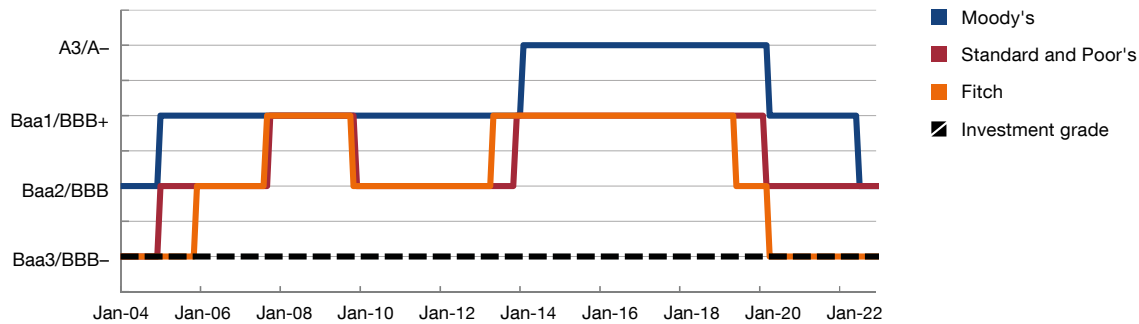

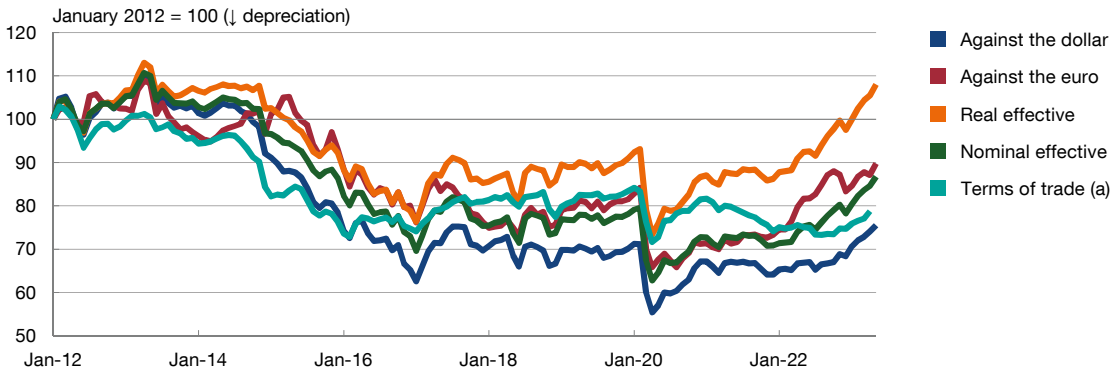

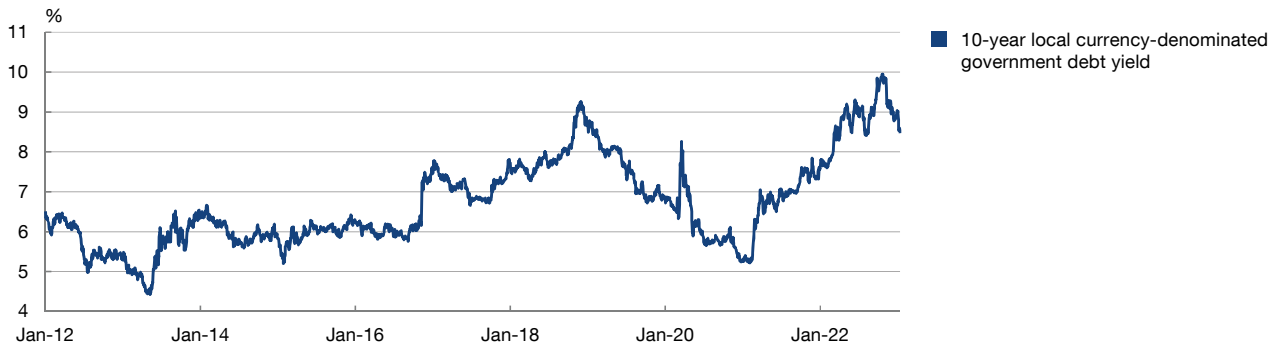

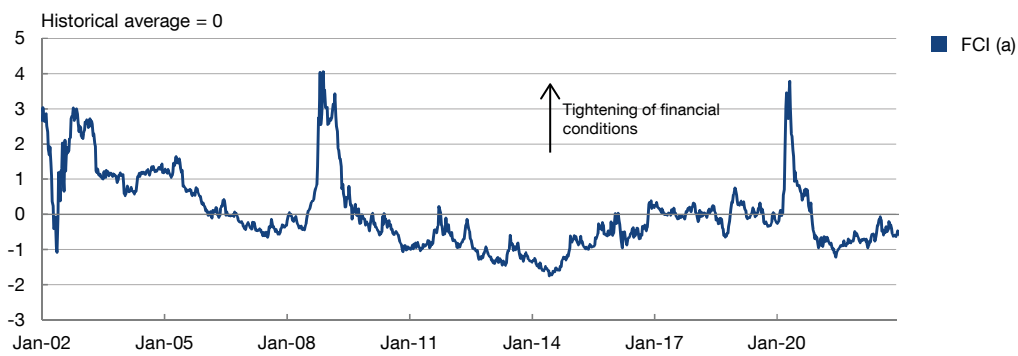

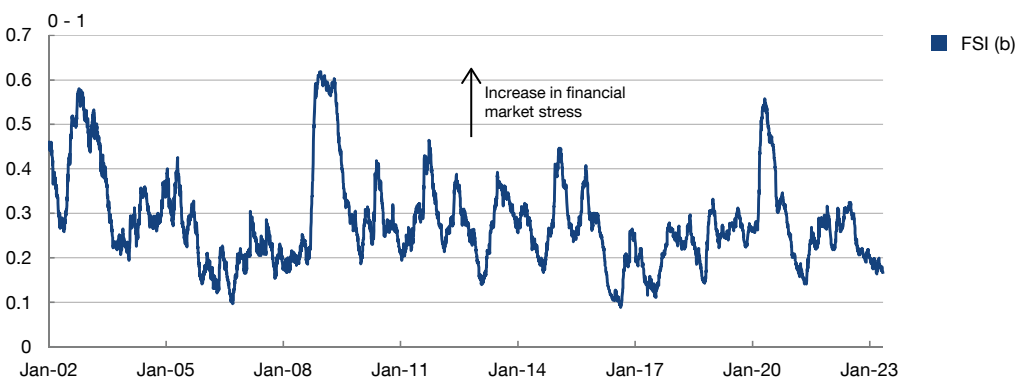
4.d Long-term interest rate in local currency
